We are kicking the Convening off at **12PM on Friday October 14th** with lunch and a Women in Politics panel- which includes **Nancy Gertner**, Criminal Justice Advisor to Hillary Clinton and **Anita McBride**, former Chief of Staff to Laura Bush. They will be speaking on topics such as whether the 2016 Presidential Election is a referendum on women in politics, gendered stereotypes about power, and what this election means for woman around the world.
