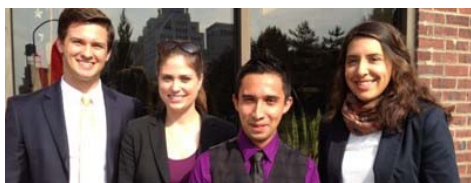

Penn Law alum selected for prestigious Bristow Fellowship

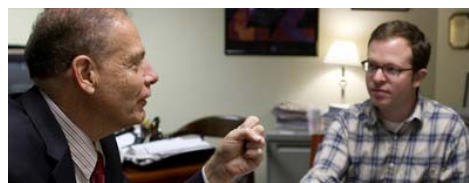
Parker Rider-Longmaid L'13 is one of four fellows selected to work in the Office of the Solicitor General.
