

## LEASE.

*Covenants running with the Land.*—A covenant on the part of lessees, to pay taxes and assessments, ordinary and extraordinary, is a covenant real, running with the land, and an action can be maintained on it, by the lessor, against an *assignee* of the lessees; but not against an *under-tenant* of the lessees, or against an *assignee* of such *under-tenant*: *Martin and Others v. O'Conner*, 43 Barb.
