

Since the code, it is not necessary that the right should be first established in a suit at law: *Id.*

The fact that the stream would not be put to any artificial use, when restored, by those entitled to its restoration, and that such restoration would be of slight advantage to them, and cause great injury and loss to the parties wrongfully diverting it, is no valid objection in equity, to decreeing such mandatory injunction: *Id.*
