

## RIVER.

*Boundaries.*—The line of the riparian owner of land in this State, bounded by the Ohio river, extends at least to low water mark: *Ensminger v. People*, 47 Ills.

*Riparian Owner.*—The riparian owner, thus having the title to the land between high and low water-mark, and the right to the exclusive use thereof, has the right to establish a private wharf thereon, and make reasonable charges for its use by those navigating the river: *Id.*

While the property of the riparian owner in the bed of the river to the *flum aquæ*, is subservient to the use of the public as a highway for the purposes of navigation, still the banks of the river are not under, or subject to, that servitude. To be entitled to the use of the banks, the right must be acquired by agreement, prescription, or grant: *Id.*

The riparian owner having the right to the exclusive use of the banks to low water-mark, a person navigating the river can not land against the will of the riparian owner, and becomes a trespasser if he does so without his consent: *Id.*
