

wool, and commencing the manufacture thereof, lost its identity and become changed into a new product, before the transfer by the assignees to the defendant, so as to prevent the plaintiff from rescinding the sale and reclaiming the property: *Joslin v. Cowee*, 60 Barb.

What Purchasers are Protected.—It is only innocent purchasers, who purchase property converted into a different species, that can be protected; and not even an innocent purchaser is so protected, who takes the title from a trespasser or wrongdoer, because the trespasser had none to give: *Id.*

Rights of Vendor.—The owner of the original material may still retake it in its improved state, or he may recover its improved value: *Id.*
