There is nothing which so much conduces to the quiet, orderly, speedy and understanding trial of actions, as to have the counsel fully instructed in the rules of practice, and according to our observation, there is no subject in regard to which there is, commonly, greater deficiency. We do not expect, that such a work will be found equally useful in other states, but there is much in it which will be found of great interest in every state, and especially where the practice is governed by a code, as is now very general throughout the country. And as all these codes are based upon that of New York, the differences are very slight.
