

he cannot permit the estate to be sold for taxes, and by purchasing it on such sale acquire a title against the mortgagee: *Dunn v. Snell*, 74 Me.

Neither can a tenant for life or for years, thus acquire a title against the reversioner, nor a tenant of the mortgagor against the mortgagee: *Id.*
