

compiler into the sub-heads: Accident, Fire, Assessment Orders and Associations, Life, Marine and Miscellaneous, but no further attempt at classification has been made, the inquirer being directed to a carefully prepared index for guidance to the principles developed in the cases. The field covered by the digest is a large one, and no reports seem to have been left unopened in the quest of cases, nor have the many legal periodicals been overlooked. While such a work is in itself of no more than passing utility, in connection with the former volumes, a library of insurance law is at hand in which almost every question affecting insurance companies is the subject of judicial opinion.
