This pamphlet is made up of two Rhodes lectures, delivered at University College, London, by the author, during May, 1921, the first being a comparison between the Supreme Court of the United States and the Permanent Court of International Justice, and the second being a similar comparison between the Permanent Court and the Court established in 1907 by the five States of Central America.

To these discussions are appended extracts from the Articles of Confederation, the Constitution of the United States, the Covenant of the League of Nations and the Draft Scheme for the Institution of a Permanent Court of International Justice; also the Statute for the Permanent Court of International Justice, adopted by the Council at its meeting of December 14, 1920.
