Arbitration in Asia has grown tremendously in recent years. The International Chamber of Commerce has revealed that South and East Asia both saw an increase in 22% of party representation. With this growth comes new problems, and new questions on how to address these issues.

Through this lens we hope to explore the ramifications of the South China Sea Arbitration, which ruled that China's territorial claims in the South China Sea based on the "nine-dash line" did not have basis in the United Nations Convention on the Law of the Sea (UNCLOS). How has this case affected change, if any? What are the geopolitical ramifications of this decision?

This year's ALR Symposium will bring together experienced practitioners and scholars to discuss the legal and geopolitical challenges in arbitration in Asia.
